





"We're so very blessed to be here and be a part of this community," said. Sgt. Holcomb. "We're shown so much love and support, and we're just so overwhelmed. Most of all, I'd like to thank my wife. She's been my rock through all of this. The military spouse is the toughest of them all, not the military soldier. She has to keep it together when you're deployed, and if it wasn't for her I probably wouldn't be here."

This is the third project for combat wounded veterans and widows of fallen soldiers that the Dallas Builders Association has undertaken in partnership with Operation Finally Home.

"This particular endeavor is a long term one for us," said Dallas BA Executive Officer Phil Crome. "This is something that we're so honored to be a part of. Along with what we do for our veterans, just how it has galvanized our membership and having the opportunity to provide the American dream for folks who have sacrificed so much to protect the American dream, that's one of the highest callings I can think of in this industry."

Mike Mishler of Mishler Builders, Inc., who will construct Sgt. Holcomb's custom home, and Ronnie Lyles with Operation Finally Home each spoke on how the project has garnered the support of many throughout the community, with close to 100 percent of all the materials having been donated for the Holcomb family's future home.



## **Two Federal Agency Rule Changes That Impact You Now**

Over the past year, the Dallas Builders Association worked to make members aware of two federal agency rule changes that will have an impact on the way builders, developers and industry partners do business. Both of those rules now hit closer to home as the effective dates for the rules are now upon us.

Members are likely aware of the Association's advocacy efforts regarding the Environmental Protection Agency's and the U.S. Army Corps of Engineers' (the agencies) new definition of "waters of the U.S." under the Clean Water Act. This rule became effective on Aug. 28. On May 4 of this year, the Occupational Safety and Health Administration (OSHA) released the final rule for Confined Spaces in Construction. This rule became effective on Aug. 3 of this year; however, OSHA announced postponement of enforcement, for those making a good-faith effort to fulfill training and compliance requirements, until Oct. 2. Below are highlights of how the regulations impact our industry.

#### **OSHA Confined Spaces in Construction Rule**

On May 4, 2015, OSHA issued the final rule on Confined Spaces in Construction. As mentioned, the rule went into effect on Aug. 3, with an enforcement date of Oct. 2, based on the aforementioned stipulation. The rule has multiple new requirements and applies to a wide range of employers, including general contractors and developers.

Aptly named, but overreaching in application, the rule is aimed at employee safety in confined spaces: work areas that are not designed for continuous occupancy and may be difficult to exit in the event of an emergency. That scope can be stretched to regulate attics, tanks, stormwater drains, water mains, crawl spaces, heating, ventilation, air-conditioning ducts and pits. Basically, an area large enough for a worker to enter that has limited means of entry and/or exit.

The rule includes requirements for a permitrequired confined space when it has one or more of the following characteristics:

Contains or has a potential to contain a hazardous atmosphere;

■ Contains a material that has the potential for engulfing an entrant;

■ Has an internal configuration such that an entrant could be trapped or asphyxiated by inwardly converging walls or by a floor that slopes downward and tapers to a smaller cross-section: and/or

Contains any other recognized safety or health hazard.

As part of its general rules, the Confined Spaces standard requires employers to evaluate the jobsite to indentify confined spaces and develop a written program and permitting system for permit-required confined spaces. In addition to controlling physical hazards, employers must also conduct monitoring for atmospheric hazards in the permit-required areas. That could include the use of monitoring devices because, in the case of atmospheric monitoring for certain gases and vapors, the monitoring must be continuous. There is also a requirement to provide training for confined space entrants, attendants, supervisors and emergency duties

As mentioned above, OSHA has postponed enforcement until Oct. 2 if the employer is using a good-faith effort to fulfill training and compliance requirements. OSHA evaluates that effort based on whether the employer has at least scheduled employee David.Lehde@dallasbuilders.com

and has engaged in additional efforts to educate and protect workers when it comes to confined space hazards

NAHB has drafted a fact sheet that summarizes the rule, its application and requirements. The fact sheet can be viewed in the blog under the "Advocacy" tab on the Dallas BA website; under the post dated Aug. 18 (What Builders and Subcontractors Need To Know About OSHA's Confined Spaces Rule). A link to OSHA's final rule is also listed.

Just how lengthy and complicated is the rule? NAHB's summarized fact sheet is five pages long.

#### "Waters of the U.S."

Note: On Aug. 27, a federal judge in North Dakota granted a preliminary injunction against the "waters of the U.S." rule just hours before it was to go into effect, citing that the 13 states suing to stop the rule had a "substantial likelihood of success." However, a defiant Obama administration is taking the position that the Judge's order only applies to the 13 states that requested the injunction, and that the rule will be enforced in other states. While Texas has joined suit with others against the rule, it was not one of the 13 states in the judge's order.

A major issue for builders, developers and property owners is the new definition of "waters of the U.S." (WOTUS) under the Clean Water Act (CWA). The rule dramatically increases areas that can be claimed "waters of the United States" to include mudflats, isolated ponds and stock tanks and even man-made ditches, regardless of flow direction and rate.

The rule became effective on Aug. 28. And while more than 30 states have filed lawsuits against the rule, due to the EPA's avoiding regulatory requirements in its drafting, now that it is in effect, builders and developers will need to be aware of how it impacts them. Land development and home building involve earth moving activities. The CWA requires landowners to obtain a federal permit for activities that result in the discharge of dredged or fill material into WOTUS. Obtaining those permits are costly and cause huge delays.

If you fail to obtain the proper permit under the CWA, you could face fines of \$37,500 per day from the time the discharge occurred.

Previously, features such as isolated ponds, wetlands and even dry channels that only get small water flow in times of heavy rain were only jurisdictional if the government could prove a significant nexus to downstream waters. Now, those features have a much greater likeliness of falling under automatic jurisdiction due to the new regulatory definitions regarding tributaries and adjacency.

NAHB has drafted an outline to inform members what they need to know in preparing to comply with the "waters of the U.S." re-definition. The information be viewed in the blog under the "Advocacy" tab on DallasBuilders.com; under the post dated Aug. 28 (New Definition of "Waters of the U.S." Becomes Effective Aug. 28).







## **Energy Series continues Sept. 29**

This month, the Association's new Energy Series continues its examination of the 2015 energy code changes and how they will impact the housing industry.

On Sept. 29 the Dallas BA's second class in the four-part Energy Series, Airtight Code Requirements, will compare new differences in prescriptive and performance path methods while reviewing the IECC, table R402.4.1.1 checklist.

This course is AIA accredited and will be instructed by Matt Brown of the American Plywood Association and a panel of builder experts. A blower door demonstration by Fox Energy Specialists will also be given.

"All sectors of the industry will be impacted by the change from the 2009 International ECC (IECC) to the much more stringent 2015 code," explains Dallas BA staff Director of Education Sheena Beaver. "The new code is set to make homes 30 percent more efficient and reduce air infiltration. Building techniques will drastically change in the Dallas/Fort Worth market.

"With the passage of HB 1736 all builders and subcontractors need to educate themselves about how to reach three air changes per hour along with a plethora of energy code changes.," she said.

The third class in the series will feature building science expert Doug Garrett with Building Performance & Comfort, Inc. of Austin, who will discuss proper ventilation. This class will ensure you are up-to-date with the new HVAC calculations and are purchasing a legitimate unit size.

The fourth and final class of the series is designed to educate the industry on what cost changes to expect in order to pass inspection. A panel of expert builders will discuss how they market these homes and where they feel money is best spent on products and design.
