

Energy Series Continuing Education — Are you ready for the 2015 IECC?

We are fast approaching the September deadline for implementation of the 2015 IECC and the new requirement to meet three air changes per hour. This new requirement means big changes in the DFW new construction market with increased costs and more testing.

Meeting three air changes per hour is no easy feat and will require training in all industry sectors from the general contractor and subcontractors. We encourage you to ask your trades to attend the 2016 energy series classes to help ensure you pass inspection.

The Education Committee has developed four classes to help educate our members and help them gain a Certificate of Occupancy the first time, every time.

On March 24 we will be looking into the regulation requirements of HR 1736 and the major changes from the 2009 IECC to the 2015 IECC.

March 2016

On April 13 join us to learn detailed techniques on how to build a tighter house and how to achieve the rigid standard of three air changes per hour.

Once the home is tightened up according to code it's imperative to ventilate it properly to avoid off-gassing and humidity dangers. The May 17 class will focus on proper ventilation.

The final class in the series will discuss the costs associated with moving to the 2015 code, and a comprehensive analysis will be given from Dow Building Solutions on the Twelve Energy Efficient Test Homes Project they developed to gauge different efficiency techniques.



Residential Development Facing Mixed Bag of Local and Federal Issues

With the first two months of 2016 marked off the calendar, proposals and actions related to both local and federal regulations that impact home building are moving quickly.

Proposed Changes in Frisco and Plano

Collin County is a fast growing region. Any changes that impact residential development should be carefully considered. This is why the Dallas Builders Association has been in communication with both Frisco and Plano regarding proposed amendments.

In early February, Dallas BA submitted comments voicing industry concerns about proposed amendments to the city's stormwater ordinance. Frisco's proposed changes include a required \$500 deposit for work found to be in violation and additional requirements added to work in the right-of-way, including having the street swept at the end of each day, even if there is inlet protection.

In our initial comments, Dallas BA opposed the use of a deposit and urged that provisions we see as problematic be removed or changed, but also that there be an extended grace period before any implementation.

The City of Plano is currently considering changes to landscape and tree ordinances, as well as changes to structure facades. While changes to the tree ordinance, such as reducing the minimum caliper of tree along a street's right-of-way from three caliper inches to two, might be good changes for multifamily, other changes mandate the number of trees in a parking lot's boundary and the removal of hackberry and cottonwood trees from the list of species exempt from mitigation requirements will add to the cost of

Plano's proposed facade changes contain language that would increase the requirement for exterior masonry material.

The Association is engaging the city on both issues

Federal Issues Impacting Residential **Development**

Remodelers who have undergone the Environmental Protection Agency's (EPA) certification training in order to work on homes that may contain lead paint, as required by the Lead: Renovation, Repair and Painting (RRP) rule, finally have some good news. The EPA recently made a change, allowing the option for currently certified remodelers to complete recertification training online. Remodelers who chose to use the online refresher course will obtain a recertification that is valid for only three years, as compared to the five years for hands-on training courses. Online re-certification can only be used every other training cycle. It is important to note that remodelers who received certification due to be grandfathered under a HUD or EPA training course prior to the implementation of the RRP rule must seek recertification via a hands-on training course.

The National Association of Home Builders (NAHB) has a helpful webpage on what remodelers need to know about RRP recertification. You can find a link to that webpage by viewing the Feb. 23 blog post under the Advocacy tab at www.DallasBuilders.com.

In early February, the White House Office of Management and Budget released final rulemaking related to the Endangered Species Act (ESA). The rules could result in a much broader interpretation

of what could be designated as "Critical Habitat." While a critical habitat designation does not create a reserve or alter land ownership, it would require a private landowner to address the loss of critical habitat when seeking a permit from a federal agency. This could mean more difficulty for developers and builders when applying for federal wetland permits.

Of key concern is how the regulatory definition of destruction or adverse modification is applied in relation to the concept of an unoccupied habitat. The new rules expand the types of habitat that can be designated as critical by allowing federal regulators to go beyond the historical criteria that an area is occupied by a listed species and if that area contains the environmental features to actually be considered necessary. U.S. Fish and Wildlife Service and National Oceanic and Atmospheric Administration could interpret the new rules to include an area with the assessment that it could eventually develop those physical or biological features.

As a result of these regulations, landowners and states will face more difficulty in refuting a federal assessment attempting to designate land as a Critical Habitat. Dallas BA is working with NAHB to secure more information for members and policy makers.

The rules on critical habitat will have an impact on the "waters of the United States" (WOTUS) rule change. WOTUS went into effect last year, but fell under a nationwide injunction by the U.S. Court of Appeals for the 6th Circuit. In late February, the same court decided to hear legal challenges to WOTUS. Many would prefer that the challenges first be heard at the district court level where multiple lawsuits have been filed. The 6th Circuit, however, has agreed with the Environmental Protection Agency and the U.S. Army Corps of Engineers that the jurisdiction is exclusive to the 6th Circuit. While the challenges that lead to the nationwide stay will be heard at the appeals level, a case in the 11th Circuit remains pending. That case involves 11 states seeking to overturn a district judge's ruling that their challenges should be heard by an appeals court, rather than the multiple challenges being heard at the district level first.

A February U.S. Supreme Court decision brought regulatory relief to states and industries including home building. The Court weighed in on the controversial Clean Power Plan Rule, halting its implementation

The Clean Power Plan Rule, which dictates onerous requirements for states to reduce emissions from power plants within their respective borders, can have a direct impact on home building. The EPA's rules contain incentives for states to use energy efficiency to meet the requirements, although not as much as drafted, thanks to home builder advocacy. Still, there is concern that the remaining incentives could lead to states considering demand-side energy efficiency. Translation: Stricter building energy codes.

NAHB had joined other parties in filing a petition of review at the circuit court level. States joined industry groups in seeking to halt implementation while the rule is being litigated. The Supreme Court's decision means states can hold off from immediate action to meet the deadlines of the Clean Power Plan Rule until after courts decide on the rule's legality.


