Dues payments to the Dallas Builders Association (DBA) are not deductible as charitable contributions for federal income tax purposes. However, dues payments may be deductible as ordinary and necessary business expenses, subject to the exclusion for lobbying activity. A portion of your dues is used for lobbying activities (but not for campaign contributions) by the National Association of Home Builders (NAHB), the Texas Association of Builders (TAB), and the Dallas Builders Association (DBA). For 2026, the non-deductible portion of dues is as follows: NAHB: 15% of dues (\$29.70); TAB: 67% of dues (\$138.02); DBA: 6% of dues. For 2026, NAHB dues are \$198.00, and TAB dues are \$206.00. DBA dues are the remaining balance after \$404.00 (NAHB and TAB dues combined) is subtracted from the total amount paid. Please consult your tax professional for guidance regarding the deductibility of your dues.

- Members shall help to educate the public and shall speak out as individual citizens on issues affecting housing quality and affordability.
- Members shall not knowingly engage in activities that detract from the Association's mission of enhancing the positive image of the industry and its members through training and encouraging ethical behavior and professional standards. This includes, but is not limited to, dissemination of Association educational programs, periodicals and events without prior express written authorization.
